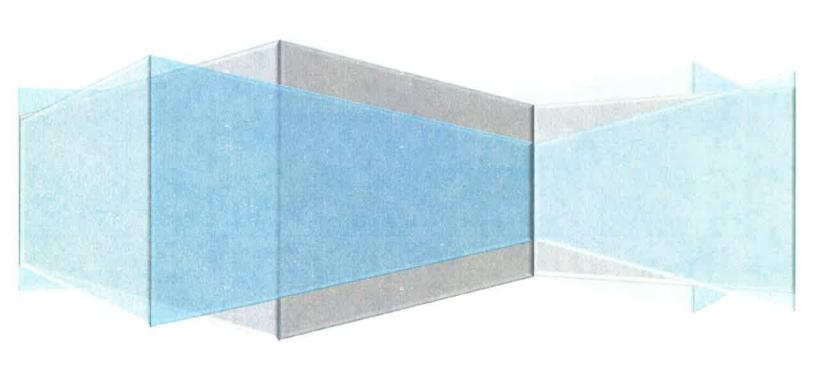

# PREA: 2013 ANNUAL REPORT



The Prison Rape Elimination Act (PREA) of September 4, 2003, (Public Law 108-79) was enacted by Congress to address the problem of sexual assault in all US correctional facilities.

PREA supports the reduction, prevention, and ultimately the elimination of sexual assault and rape within our prisons, community corrections centers and local jails. PREA applies to instances of offender-on-offender, and volunteer, contractor and staff-on-offender sexual misconduct.

In May 2012, the final report and publication of national standards under the PREA was completed and made public. With this publication, correctional facilities across the nation implemented procedures to demonstrate compliance with these standards and sought certification as compliant agencies by U.S. Department of Justice.

For CCA, sexual abuse has been an area of significant focus for years, and our company had taken many concrete steps to begin implementing the concepts addressed in the regulation prior to the publication of the national standards. For instance, CCA established an agency wide PREA Coordinator based in our corporate headquarters, and at each facility, CCA put in place a PREA Compliance Manager, as well a Sexual Abuse Response Team. Additionally, those serving in these roles were provided specialized training to help them carry out their responsibilities effectively.

Facilities were examined for vulnerabilities, and corrective actions were taken to strengthen identified concerns. This included the addition of video cameras, placement of mirrors, and modifications to our shower and restroom facilities to enhance privacy and reduce the risk of cross gender viewing by staff performing their duties.

CCA is committed to eliminating sexual abuse and sexual harassment in our facilities. For years, we have had a zero tolerance standard for sexual abuse and sexual harassment. This standard is codified in CCA's Policy 14-2, Sexual Abuse Prevention and Response, and available for review via the link provided on our webpage.

In 2013, CCA incorporated the national standards into our internal quality assurance process which includes an annual review of each facility by audit staff not assigned to the institution. This review permits facilities to be measured against set objectives annually and take pro-active steps to ensure continuous quality improvement.

Training and education are also critical components to the prevention of sexual abuse. CCA revised and updated all PREA lesson plans to ensure staff, contractors, and volunteers are fully educated and prepared to execute their responsibilities under PREA. Inmates are educated from day one and throughout their incarceration regarding their right to be free from sexual abuse and sexual harassment and how to report any incidents or concerns that may arise while in a CCA facility.

In 2013, CCA hosted a large scale, week long emergency preparedness exercise at our unoccupied Diamondback facility in Oklahoma. More than 500 staff representing every facility owned, operated, or managed by CCA participated in this exercise. As part of the training, investigators from each facility received in depth specialized training to ensure they were prepared to conduct quality investigations into all allegations of sexual abuse or sexual harassment. This training has been subsequently provided via Webinar for investigators and facility managers across the organization.

CCA has also developed and implemented specialty training related to the role of health care staff and contractors in detecting, reporting, and preserving medical forensic evidence. This training also addresses responding professionally and appropriately to the needs of persons who either report or are suspected of being a victim or perpetrator of sexual abuse.

The steps we are taking are intended to create a culture where reporting concerns regarding sexual abuse or sexual harassment is encouraged. Our company has worked to stay on the leading edge of efforts to eliminate inmate sexual abuse by establishing and maintaining a sexual abuse prevention program, which includes reporting methods, inmate awareness initiatives, staff training programs, inmate education, investigation procedures and audit processes.

2013 represents the first opportunity to provide a complete calendar year of data under the new PREA national standards. This report will serve as our baseline for subsequent reporting years. It includes data collected facility-by-facility as required by Standards 115.87 through 115.89. Additionally, as a result of the data review, policy changes have been initiated and procedures implemented to ensure enhanced effectiveness of video surveillance.

At CCA, we take seriously our responsibility to respect and uphold the rights and welfare of inmates and detainees in our care, and preventing sexual abuse is a critical component of that effort.

#### Notes:

# Scope of this report:

CCA operates six facilities which house only Immigration Customs Enforcement (ICE) detainees. These ICE detainees fall under the authority of the Department of Homeland Security (DHS). The PREA standards for the DHS did not go into effect until March 2014 and differ from the PREA standards established for the Department of Justice; therefore, data from these facilities are not included in this report. Additionally, during 2013, six facilities (San Diego Correctional Facility, Florence Correctional Center, Central Arizona Detention Facility, Nevada Southern Detention Center, Torrance County Detention Facility, and Webb County Detention Center) maintained a population partially consisting of ICE detainees. This report does not include data from ICE detainees at these facilities. All ICE detainee allegations will be included in future reporting, consistent with the applicable standards.

In circumstances where a single incident contained multiple allegations, all allegations are reported separately.

## Investigations:

In all instances of alleged PREA violations which, if substantiated, would constitute a criminal act, CCA notifies and works closely with jurisdictionally appropriate law enforcement agencies as well as CCA's government partner. In such cases, CCA invites law enforcement agencies to carry out the official investigation on-site, and make the final determination as to the validity of the alleged PREA violations.

### <u>Definitions of PREA Incident types:</u>

Substantiated: An allegation that was investigated and determined to have occurred.

Unsubstantiated: An allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the incident occurred.

Unfounded: An allegation that was investigated and determined not to have occurred.

Ongoing: Investigation has not been completed.
