Our Motion for Summary Judgment was granted. Plaintiff filed an appeal to the Sixth Circuit Court of Appeals. We filed a motion to dismiss the appeal because there is no final, appealable judgment, as the case is still pending against the co-Defendant. The Court of Appeals granted our motion to dismiss in early January 2011. Co-Defendant Jermaine Hughey (who attacked Wilhite) filed a motion to dismiss (that was remarkably similar to CCA's motion to dismiss), and that motion has been pending since November 2010. Until that motion is ruled on, we do not have a final appealable order and are thus left to monitor this case.
